Call to Order – 7:00 p.m.

Minutes from the Regular Meeting on May 18th, 2020 - Res. #20-046

Mr. Kohler moved and Mrs. Mullenhour seconded a motion to approve the minutes from the Regular meeting held on May 18th, 2020. Roll call – 5-0. Motion carried.

Public hearing on the use of Special Education IDEA Part B Funds

Per requirement, time was provided for a public hearing for the use of special education IDEA part B funds. There were no public comments on this topic.

Consideration for Approval – 2020-2021 Lunch Prices - Res. #20-047

Mr. Wren moved and Mr. Kohler seconded a motion approving that lunch prices remain the same for the 2020-2021 school year. \$2.35 (K-3) \$2.60 (4-12) \$2.75 (Ala Carte) \$3.00 (Adult) Roll call – 5-0. Motion carried.

Mrs. Mullenhour moved and Mrs. Davis seconded a motion approving a transfer of up to \$55,000 from the general fund into the cafeteria fund. Roll call – 5-0. Motion carried.

Mr. Wren moved and Mr. Ware seconded a motion approving the financial report as presented. Discussions continue on the potential impact of the pandemic on FY21 state support for schools. A kickoff meeting was held the morning of June 15th on the year long process to implement new payroll and accounting systems. The target for full implementation is June of 2021. Roll call – 5-0. Motion carried.

Reports & Information Items: 4-12 Principal Reese shared that several of the athletic programs had begun workouts or practices in accordance with established guidelines and with written parental

consent. Other non-athletic groups or clubs are also making plans to move forward with a similar approach. Superintendent Reichert shared with the Board that most schools in this areas were collaborating and working hard toward trying to resume school in the fall on site and minimize blended learning unless necessary.
